

AMENDMENT TO  
FIRM TRANSPORTATION SERVICE AGREEMENT

Rate Schedule KRF-1

CONTRACT NO. 26011

THIS AMENDMENT ("Amendment") is made and entered into as of this 15th day of March, 2021, by and between KERN RIVER GAS TRANSMISSION COMPANY ("Transporter") and EDF TRADING NORTH AMERICA, LLC ("Shipper").

WHEREAS, Transporter and Shipper have agreed to amend Section 1.1 and Exhibit "A" of this Agreement to reduce the Demand Maximum Daily Quantity ("DMDQ") and the receipt and delivery entitlements for the period June 1, 2021, through October 31, 2021.

NOW, THEREFORE, in consideration of the mutual covenants and agreements as herein set forth, the parties agree as follows:

1. This Amendment supersedes Section 1.1 and shall be deleted in its entirety and replaced with the following:

Subject to the terms, conditions and limitations hereof, Transporter agrees to receive, on a firm basis, from Shipper for Transportation at the Receipt Point(s) specified in Exhibit "A" and to transport and deliver Thermally Equivalent Quantities to Shipper at the Delivery Point(s) specified in Exhibit "A," Quantities of Natural Gas, exclusive of Quantities required for fuel used and lost and unaccounted-for Gas, up to Shipper's DMDQ. Shipper's DMDQ is set forth on Exhibit "A."

2. Effective June 1, 2021, through October 31, 2021, the Agreement is amended as follows:
  - a. For the period June 1, 2021, through October 31, 2021, Shipper's entitlements shall be set forth on Exhibit A attached hereto. Exhibit A shall supersede and replace any previously effective Exhibit A.

3. This Amendment constitutes the entire agreement between the parties with respect to the subject matter of this Amendment and shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns. No promises, agreements or warranties additional to this Amendment other than as may be contained in Transporter's Tariff will be deemed to be a part of this Amendment, nor will any alteration, amendment or modification be effective unless confirmed in writing by the parties.

Except as amended herein, all provisions of the Agreement are hereby confirmed by the parties to be and remain in full force and effect.
